NOT YET KNOWN. THE LARGE CASINO WILL BE AN INTEGRAL PART OF THE LEISURE AND ENTERTAINMENT DEVELOPMENT CALLED "THE EDGE"

THE LARGE CASINO PREMISES ARE PLANNED TO BE DEVELOPED IN A NEW LEISURE AND ENTERTAINMENT COMPLEX, THE EDGE, ON VACANT LAND IMMEDIATELY TO THE SOUTH OF THE PLEASURE BEACH, SOUTH BEACH PARADE, GREAT YARMOUTH, NORFOLK, NR30 3EH. THIS IS BORDERED BY SOUTH BEACH PARADE TO THE WEST AND THE BEACH AND SEA TO THE EAST.

THE CASINO PREMISES WILL BE SITED ON THE GROUND FLOOR LEVEL WITH THE ENTRANCE ACCESSED FROM THE STREET LEVEL. THERE WILL BE ADJACENT TO THE CASINO, BUT IN SEPARATE BUILDINGS, RESTAURANTS, CINEMA, BOWLING ALLEY AND A SIX STOREY HOTEL.

THE LARGE CASINO PREMISES ARE PLANNED TO BE DEVELOPED IN A NEW LEISURE AND ENTERTAINMENT COMPLEX, THE EDGE, ON VACANT LAND IMMEDIATELY TO THE SOUTH OF THE PLEASURE BEACH, SOUTH BEACH PARADE, GREAT YARMOUTH, NORFOLK NR30 3EH. THE DEVELOPMENT WILL BE A MIXED USE LEISURE AND ENTERTAINMENT SCHEME INCORPORATING A LARGE CASINO, CINEMA, RESTAURANTS/BARS, OTHER D2 USES SUCH AS BOWLING, A 6 STOREY HOTEL WITH CONFERENCE FACILITIES, AND A MULTI-STOREY CAR PARK.

IN TOTAL THE SCHEME WILL COMPRISE 5 SEPARATE COMPONENTS:

- 1. The Multi-Storey Car Park**
- 2. The Hotel**
- 3. The Large Casino**
- 4. Restaurants/bars**
- 5. The family entertainment centre comprising Cinema and other D2 uses such as bowling.**

THE LARGE CASINO PREMISES WILL BE A SELF CONTAINED SINGLE STOREY RECTANGULAR SHAPE BUILDING. THE CASINO BLOCK WILL BE SITUATED AT THE SOUTHERN END OF THE DEVELOPMENT BEFORE THE HOTEL. THE CASINO WILL HAVE ITS ENTRANCE FROM SOUTH BEACH PARADE AND WILL HAVE A CONTROLLED LOBBY AREA.

TO THE NORTH OF THE CASINO ARE TWO SEPARATE BLOCKS WITH A PEDESTRIAN WALKWAY IN BETWEEN THEM. THE FIRST BLOCK WILL BE SINGLE STOREY, WHICH WILL ACCOMMODATE THE RESTAURANTS AND BARS. THEN THERE WILL BE THE PEDESTRIAN WALKWAY, THEN THE SECOND BLOCK WHICH WILL BE BUILT AT ITS FURTHEST POINT ADJACENT TO THE SCENIC RAILWAY ROLLER COASTER. THIS WILL BE A RECTANGULAR SHAPE TWO STOREY BUILDING HOUSING THE D2 USES WITH THE CINEMA AND TWO RESTAURANTS AT FIRST FLOOR AND THE OTHER D2 USES SUCH AS BOWLING AT THE GROUND FLOOR. THE ENTRANCE TO BOTH BLOCKS WILL BE FROM THE CENTRAL PEDESTRIANISED MALL.

IMMEDIATELY ADJACENT TO THE SOUTH OF THE CASINO WILL BE A 6 STOREY HOTEL AND FURTHER SOUTH OF THE HOTEL WILL BE THE MUTLI-STOREY CAR PARK.
